### *Steve Colvin of Boston Properties Elected President*

**San Francisco, December 10, 2003** – The Building Owners and Managers Association (BOMA) of San Francisco announced today that Steven R. He currently chairs BOMA San Francisco's political action committee, BOMA-SF-PAC. With more than 30 years experience in commercial real estate, he joined Colliers International from the George Elkins Property Management Company, where he served as managing director.

Ms. Mattes serves as general manager for Flynn Properties, Inc., where she is responsible for managing a portfolio of four properties in San Francisco, which total 900,000 square feet. Prior to joining Flynn Properties, she served as general manager of China Basin Landing. Ms. Mattes achieved the professional designation of Certified Property Manager from the Institute of Real Estate Management, and she is a Certified Commercial Investment Manager. She holds an MBA in Real Estate from Golden Gate University, and she is an active member of the San Francisco chapter of Commercial Real Estate Women (CREW).
